6 New Business

6.1 Competition Structure 2018

- Team nominations must be finalised by 26th March by all clubs.
- There are concerns with the Division 1 women's competition again this year. At this time there are indications of 3 teams only. If this remains, the women's competition will be forced into a 2 division competition.

6.2 2018 playing fees

• Document has previously been circulated to clubs

- The association fee remains unchasnged from last season. There is a small increase in the Hockey NSW registration fee.
- Proposal to add the Wagga Association fee to the registration fee which will need to be paid in 1 payment before players take the field.
- This would assist with cash flow to the association for improvements to the facilities that were agreed and endorsed last year.
- Feedback from Cavaliers is that this was not supported by the members.
- Second option is that all clubs must pay the WWCHA fee by round 1.
- Feedback that this will ease the burden on clubs having to chase players for the association fee.
