6.0 New Business

6.1 2018 Competition Survey Results/Outcomes

- President outlined key findings
- Less than 1/3 of WWCHA members completed the survey
- Mixed opinions with many 'unsure' responses
- Mixed competition during the week should be considered as an option in future
- Consideration for surveys in future identify gender and identify member no.

6.2 Junior Survey Results

- Development Manager outlined key findings/actions
- The strongest take-home point to come out of the survey for the clubs is the dire need to set up active recruitment strategies.
- For the following question to the junior community: "Which senior club are you currently aligned to? (Either your child is already playing for them or have parents/family in that club)"
 - > 35% of respondents indicated that they have NO affiliation to any club.
 - However, there seems to be no competition between clubs to recruit juniors.
 - Other than our key junior coaches, there is little to no interest in junior participation. We risk straight up losing 35% of our juniors just because clubs aren't prepared to recruit players.
 - Royals and Rosellas were the best represented with a tick over 20% market share each, while all other clubs struggled to 5%
 - > Some key themes to come out of the comments:
 - Many parents felt they didn't know how to approach clubs
 - Many parents didn't know training details of the senior clubs
 - The follow up question: "What clubs (you can select more than one) appear most appealing to you at the moment for transitioning your child into the senior competition?"
 - Family connections and family atmosphere came up as the biggest factor influencing senior club choice.
 - However, the kids that have no family playing hockey...Only Royals (Pat O'Donnell) had identifiable junior training programs.

- Proposed ideas from the Development Manager:
 - Clubs are encouraged to utilise their third grade men and women coaches to attend U16 games and scout for players? Especially for men this would ease the requirement of women making up the numbers in the mens competition
 - Clubs are encouraged to attend the odd training and lend a hand and pass out some pamphlets about your club
 - Clubs are encouraged to send someone from your club along to the inter-schools competition late in the year and pass out some pamphlets to the kids after the games (there is a lot of raw hockey potential)

Eventually we need to hand the junior development back to the clubs, but given the results of this survey we have a long way to go to reach that distant goal. Otherwise, results of the survey have identified preferred communication channels, helped form the wet-weather policy (to be released at Feb general meeting), and identified areas for improvement including training and general feedback for the junior competition.

6.3 Competition Structure 2019

- Framework for discussion and voting:
 - Women not to be allowed to play in Men's competition
 - Point raised about Mustangs not being present to vote
 - Motion moved that from 2019 women will no longer play in the mens competition
