- Men's Competition Proposal
- 1. Division 1 Men
 - a. Harlequins have requested for a nominated 4-5 people in their division 1 team. They do not have the numbers for the required 9.
 - b. Harlequins have two division 2 teams that appear to be true division 2 teams. I.e. it would be an unfair competition for other division 3 teams if either team were moved into div 3. They would be able to fill their div 1 team from two division 2 teams. Moving the Development Div 2 team to Div 1 would inhibit Harlequins ability to coach and mentor these in-between players to be ready to move into Division 1 in the next year or so.

2. Division 3 Men

a. Royals and Ducks have enough players for more than one team each, but not enough for two teams.

b. Harlequins will not be submitting a division 3 team.

The competitions panel have discussed the possibilities. We propose that all Division 1 Men teams are allowed 7 player nominations, with Harlequins still supplying 5 nominated players. This is based on the precedent set with Rosellas Division 1 being approved for 5 nominated players in previous seasons. If Harlequins are able to recruit any more players this season, they will be reviewed; if they are Div 1 quality, Harlequins minimum nominated players will increase by one, up to seven to align with the other clubs.

The 7 nominated players for each division 1 men's team will allow clubs to move a few players down to help get division 3 off the ground. We are proposing that the extra players in division 3 in Royals Cavaliers and Ducks can be merged into a Dolphins team.

Juniors that are old enough to move into Division 3 have also been approached.

One last option is to make Division 3 9-a-side for the first few weeks, with the hopes that people seeing that Division 3 has started will bring in more players. Once the player numbers have stabilized, we could increase the competition back to 11 a side upon consensus.

• GoalKeeping Pool Proposal

With the intention to promote goalkeeping, to give more opportunities to our current goalkeepers and those who like to play both GK and field we would like to propose a Goalkeeping Pool. This will also take into consideration that Goalkeepers are not available every week and take some pressure from them. The purpose of the Goalkeeper Pool is an 'emergency supply' when dedicated goalkeepers are away or sick.

- 1. WWCHA Playing Rules currently state that a player cannot play for another club or team in the same division. Clubs may submit a list of players into the goalkeeper pool, with an exemption request for this rule at the start of the season.
- 2. Any Goalkeeper can nominate themselves into the goalkeeper pool. A goalkeeper is not required to participate in the goalkeeper pool.
- 3. Teams are encouraged to nominate their own Goalkeeper. The Goalkeeper pool may be used when the nominated goalkeeper is unavailable.
- 4. A Goalkeeper from the pool that is not nominated in the club cannot play during the finals series.
- A Goalkeeper that is nominated in the pool must be assigned a division. Normal rules would apply.
 E.G. If a goalkeeper is nominated in Men's Division 2, they may only assist teams that are in Men's Division 2 or 1, they are not allowed to play in Men's Division 3.
- 6. A team is not required to use a goalkeeper from the pool if they do not have a goalkeeper available.

For further discussion:

- Should the goalkeeper pool only apply to Div 2 and lower? I.E. Clubs may only use goalkeepers from their own lower divisions to fill in for Div 1 Goalkeepers?
