6 New Business

6.1 2018 Competition Structure

- Numbers across the clubs have been declining each season. There are a number of people playing across divisions. Clubs are struggling to field 11 players each week
- The competition is at risk of not being able to run the current divisions next season
- The board would like clubs to think about possible solutions for the competition next year
- This is also impacting on clubs ability to meet umpire committments
- What can be done better to attract new players and keep people playing?
- The rotating timeslots have impacted on some clubs being able to field teams due to player work commitments

6.2 Umpiring Committments

- There continues to be clubs that are not supplying their rostered umpire duties
- The following penalties will be applied as per the competition rules **Competition:**

Failure of a club to do their umpiring duties will result in:

- First offence: Loss of two (2) competition points for offending team
- Second offence: \$40 fine to offending club.
- Third offence: \$80 fine to offending club & 1 match suspension to captain of offending team.
