President

- The WWCHA Playing rules have been updated and have been placed on the website. The Constitution has also had some minor updates to reflect the change in AGM date.
- There have been a number of break-ins around the grounds with holes cut through the fences. Council have been contacted to work through the repairs.
- There is a current player safety concern regarding the drainage at both ends
 of the Paul filed as well as the state of the current mesh fencing around the
 fields.
- The Board are seeking approval to replace the existing fences around the fields (see image below) and cement the drains behind the Paul filed.
- Indicative costs for these works are cementing \$8,000 and replace fencing \$20,000. Total approximate spend \$28,000
