Indoor Competition commenced - update

- Look at using the come and try format to limit fee payment to encourage additional community participation
- Teams to be made up each week to develop a positive cross club culture

- 8 week program- Summer of Hockey training and development program

Winter season

- Start date of 25/03/23
- Fees to be confirmed by Treasurer 5 January 2023
- Registrations to open at the beginning of March
- 16 Rounds with the grand final falling on 23 September 2023
- Promotion through High Schools and Primary school newsletters and flyers Rosie will do some preliminary investigation into schools - Bec Peel to do a budget and promotional plan by 27 February 2023
- Come and Try (Juniors) will be organised by Nathan and Liz on a Thursday or Friday night before the start date.
- Clubs need to provide team numbers to Mel by 27 February to plan for competition schedule
- CSU to provide detail around CSU dates to try and facilitate round scheduling and investigate the possibility of how the teams are structured to minimise availability interruptions.
- There are many interruptions to the season for 2023 to work around including:
 - Academy Games 21-23 April
 - U15 Boys State Championships 26-28 May
 - Long weekend in June
- Discussion around Women competition and what the format will entail. 9 a side was a compromise last year and WWCHA will be going back to 11 a side games.

5. Treasurer's Report

- No outstanding accounts
- Water repairs \$6000
- Grand stand is the next large asset project aimed for by previous committee for 2024
- Presented quote for concreting the walkway at the end of fields. Council has agreed to contribute 50%. Jacqui has requested to conduct some additional investigations into cost and options.

6. Canberra Premier League application - WWCHA endorsement

- A presentation was given to address the emergent issues around the Canberra Premier League team and application to Hockey Canberra. The presenters spoke about the positive impact that introducing the CPL to Wagga would have including:
 - i. elevating hockey to other sports in Wagga such as Basketball
 - ii. pathway development
 - iii. developing and bringing back technical skills to WWCHA
 - iv. Improved inter club relationships
 - v. Addition of a development squad
 - vi. Mentorships from a CPL player
 - vii. Media coverage
- The presenters acknowledged that the first year would include many learnings and believe that there are many examples from both Goulburn and Albury to illustrate how WWCHA can grow as an association.
- The representatives for the CPL team proposed that they would like to:
 - i. Manage their own finances
 - ii. Have their own governance for timely decisions

- iii. Have their bank account under Wagga Hockey
- iv. Explore whether WWCHA D1 Women's comp be moved to the same week night as the D1 mens will be moved to
- v. Have a 90 minute slot on:
 - 1. Saturdays between 12-3pm
 - 2. Sunday 10am to 12pm
- vi. That they would supply their own umpires
- vii. Would request the involvement of juniors to fill the roll of ball girls and boys
- Financially the CPL representatives have gained the sponsorship support from a number of local businesses and request that:
 - i. training fees be waived as they are for representative teams
 - ii. Waive fees for home games
 - iii. WWCHA pay the initial Canberra Hockey installment with scorcher to reimburse when they have cash flow
 - iv. For the WWCHA to consider a financial sponsorship this has also been requested from Wagga Clubs
- The CPL representatives requested a letter of support from WWCHA to present to Canberra Hockey as a requirement to register.
- Due to the complexity and emergent nature of some of these items the WWCHA
 President requested that we narrow the discussion to emergent items only and revisit
 other requests at the next board meeting. as a result the following was discussed and
 agreed upon:
 - i. Financially:

Facility usage fee for training and games be waived \$7000 nomination fee be paid (due April and June) - under the understanding that it will be paid back.

ii. WWCHA provide unbiased support for the Capital League competition
